### EU, environmental noise, legislation

- Directive 2002/49/EC ... relating to the assessment and management of environmental noise
  - Determination of exposure to environmental noise, through noise mapping.
  - Ensuring that information on environmental noise and its effect is made available to the public.
  - Adoption of action plans, based upon noise mapping, with a view to prevent and reduce environmental noise where necessary.
- Directive (EU) 2015/996 ... establishing common noise assessment methods
  - Define common approach to determine the exposure to environmental noise, through noise mapping.
  - Result are noise indicators L<sub>den</sub> and L<sub>night</sub>.

# REQUIREMENTS, INDICATORS, LIMITS FOR AIRPORTS





#### Airport requirements – environmental noise

- Airport with runaway longer than 2.100 m has to operate according to environmental permit, whose content are:
  - description of noise source,
  - noise limit values,
  - noise mitigation measures and
  - noise monitoring.

Airport operator has to apply for modification of environmental permit upon every major change in operation.
